

6. Materials must be delivered at Central Dairy Plant, Manipur Milk Producers' Co-operative Union Ltd., Porompat, Imphal East-795005 and works must be completed within 20 days after placement of the Supply/Work Order.

7. Payment shall be made by NEFT/ RTGS to the approved bidder within 20 days of receipt of the bill along with the materials in good condition certified by Competent Authority.

8. In the case of receipt of the materials having found of substandard quality shall be rejected upon mutual inspection. If the materials do not conform to the acceptable standard, the Materials have to be replaced by the party within 10 days.

9. If any discrepancy arises in quality of the material, MMPCU may impose a penalty and intimation shall be given to the supplier. The goods shall be accepted on fulfilling such conditions for payment of the penalty.

10. In case of any dispute between the Milk Union and the bidder, the decision of the MMPCU shall be final and binding.
