Terms and Conditions:**1. Eligibility criteria of the bidder:**

- 1.1 The vehicles must have necessary permit(s) as required under Motor Vehicle Act or any other regulation(s), rules, laws etc. of the statutory Govt authority to run as hired vehicles in Manipur Pollution Testing Certificate, PAN Card Xerox copy, Insurance, Fitness Certificate.



2. **Earnest Money Deposit (EMD):** Rs. 50,000/- (Rupees Fifty Thousand) shall be submitted in the form of Demand Draft (DD) in the name of "Manipur Milk Producers' Co-operative Union Ltd." Payable at Imphal. The EMD can be forfeited by the purchaser, if the bidder is not earnest about their bid and withdraw it before the validity period is over.
3. **Performance Security:** The transporter has to deposit an amount @ 10% of the contract value for the route as security money in the form of Demand Draft or Bank Guarantee of any Nationalized or Scheduled bank. The security money is to be deposited within 30 days of signing of the agreement. The same will be refunded within 60 days without interest on the termination of this contract subject to deduction of any claims by Manipur Milk Producers' Co-operative Union Ltd. against the transporter. The security amount is liable to be forfeited in the event of the Transporter not performing their obligations.
4. **Validity of the Quotation:** Quotation must be valid for 120 days from the due date of submission. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
5. **Contract period:** 1 Year Annual Rate Contract (on a daily hire basis) for each route. However, the agreement may be terminated by both the parties with one-month prior notice. The time limit of agreement may be extended in conscience of both the parties. If it is found that the transporter activities are against the norms of Manipur Milk Producers' Co-operative Union Ltd., the agreement may be terminated immediately without giving any notice.

6. Price Bid:

- 6.1 The Prices shall be quoted in Indian Rupees only.
- 6.2 Each bidder shall submit **quotation for one or more route**. Bidder shall not contact other bidders in matters relating to this tender.

7. Evaluation of Quotations and Award of Contract:

- 7.1 The quotation would be evaluated for full capacity of vehicle under this NIQ as referred to Format of Quotation at Annexure-II. The evaluation would be made item wise i.e. for each route separately.
- 7.2 The Purchaser will award the contract to the bidder whose quotation will be determined to be substantially responsive and who offers the lowest evaluated quotation price.
- 7.3 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 7.4 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the order.

8. **Documents:** The Quotation shall comprise two Parts, namely the Technical Part and the Financial Part. Both Parts shall be submitted simultaneously.



8.1 The Technical Part of Quotation shall comprise the following:

- Letter of Quotation – Technical Part
- Technical specification
- EMD Amount details

8.1.1 Complete address and contact details of the Bidder having the following information:

- Bidder shall submit: Self attested copy of PAN, Self-attested copy of GST, MSME Certificate (if available), Self-attested copy of Trade License, Bank Account details on letterhead of the firm and the NIQ document.

8.2 The Financial Part of Quotation shall comprise the following:

8.2.1 Price Schedule as per specified format (Annexure-II).

9. Opening and Evaluation of Technical Parts of Quotations:

The 'Technical Part' of the Quotations will be opened on the specified date and time. The Financial Part of the Quotations shall remain unopened until the subsequent technical opening.

- 9.1 The Purchaser shall examine the technical part of the quotation to determine whether the quotation has been properly signed meets the eligibility criteria conforms to all terms & conditions, Technical specifications etc.
- 9.2 Only Quotations that are both substantially responsive to the NIQ document, and meet all qualification criteria shall qualify for opening of the Financial Parts of their Quotations at the second Opening.

10. Opening and Evaluation of Financial Parts of Quotations:

- 10.1 The 'Financial Part' of the Quotations will be opened on the specified date and time. The Purchaser shall examine and confirm that Letter of Quotation – Financial Part and Price Schedules/Annexure-II are in accordance with the requirements specified in the NIQ document. If any of these documents or information is missing, the offer shall be rejected.

11. Cancellation and rejection of Contract:

Manipur Milk Producers' Co-operative Union Ltd. shall monitor the service regularly and the contract may be cancelled in case of poor service prior to one-month notice.

12. Bidder should submit:

Self-attested copy of FSSAI license, PAN, Self-attested copy of GST, Self-attested copy of Trade License, Bank Account details on letterhead of the firm, contact details and seal & signed copy of NIQ.

13. For any dispute/legal issues, the jurisdiction is at Imphal Only. The entire arbitration proceedings will be governed by the Arbitration Act in force at the time of dispute.

14. In extreme case of the bidder failing to provide transportation, Manipur Milk Producers' Co-Operative Union Limited may make alternate arrangement at the risk, cost and responsibility of the bidder. Repetition of such cases of failure for more than 3 times during the period of the contract shall make the contract liable to be terminated.
15. No price negotiation will be done with any bidder: the purchase order shall be issued to the lowest responsive bidder.
16. Each bidder shall submit only one quotation. Bidders shall not contact other bidders in matters relating to this quotation.
17. In case of any dispute between the Milk Union and the bidder, the decision of the Manipur Milk Producers' Co-Operative Union Limited shall be final and binding.
18. The Manipur Milk Producers' Co-Operative Union Limited reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.

The interested bidders should submit the bid (technical bid along with all the required supporting documents, Notice Inviting Quotations(NIQ) and the financial bid in the designated format mentioned in Annexure-II) in two (02) separately sealed envelopes and then insert them in a single large envelope duly sealed and shall address to Managing Director, Manipur Milk Producers' Co-operative Union Ltd., Dairy Complex, Porompat, Imphal East, Manipur – 795005, either through post, email (chumthangdairy@gmail.com), or in hand.

Note: It is to be noted that the technical bid and financial bid should be provided in two separately sealed envelope and in no case there should be intermixture of the same.

Annexure-I

Terms of Reference (TOR)

1. DEFINITION

- 1.1 Carriage/Trip:** The Carriage/Trip would deem to have started from the time Supplier takes the delivery of the Goods from the premises as specified in writing by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED and shall terminate upon the delivery of goods and acknowledgement of documents by the consignee at the destination as specified in writing by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED from time to time.
- 1.2 Goods:** Goods shall mean milk and milk products. The Goods and their condition shall be as described in the challan/documents issued by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED.
- 1.3 Vehicle:** Vehicle would deem to mean and include the mode of transport that is used by Supplier in the usual course of business.
- 1.4 Plant:** Manufacturing Plant of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED located at Manipur Dairy, Porompat DC Road, Imphal - 795005, Manipur.

2. RESPONSIBILITIES

- 2.1** Supplier shall take delivery of the Goods from the places specified by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED in writing from time to time and will deliver the same at the destination as specified by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED in writing to the authorized representative of the consignee. Supplier shall not make any transshipment during transit except agreed to by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED or in the event of accident or major breakdowns where product safety is in jeopardy. Supplier to ensure delivery of milk and products at all prescribed drop points in a route, in full at all times. Partial service of any route would not be considered for payment for the trip.
- 2.2** Supplier undertakes to transport the said goods/product diligently, carefully and take all reasonable precautions to protect them from rain, storm, dust, quality deterioration and damage, and maintain them at the temperature +2 to +4 Degree Celsius as long as they are entrusted to their safe custody, and accept liability for any damage either due to spoilage or otherwise to the said products entrusted to them.

Supplier is not permitted to carry other goods/commodities along with "MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED" milk

- 2.3** and milk products in view of the danger of the products getting tainted in colour, smell, taste, appearance or any other manner from contact or proximity to other goods.
- 2.4** Supplier undertakes to place their refrigerated vans at MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED's request at any time of the day or night, with reasonable prior notice, with the requisite crew thereof with the refrigerated van and all equipment functioning as per specifications. If Supplier fails to provide a refrigerated van within the specified transit time period, MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED reserves right to contact an alternate Transport Carrier to lift the consignment. In such cases, any loss or additional charges incurred by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED in dispatching the consignment, will be recovered from Supplier. In addition to the transport charges mentioned above, MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED would charge a penalty of Rs. 15,000/- per day as debit note for failure to provide vehicle for servicing.
- 2.5** In the event the Supplier fails to complete the entire route as per the route plan for the trip, payment for the trip would be considered on prorated basis, up to last serviced market by the supplier. If no market is served in the trip, no claim should be made for the trip.
- 2.6** In the event the trip is incomplete, Supplier to ensure products are returned in good condition (under refrigeration), which should be ascertained by Lab Test at MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED Dairy Laboratory. If products are found to have deteriorated, the entire value of the damaged products would be deducted from the transportation bill. And an additional 20% of the value products from Non service markets, would be deducted for non-availability of products in destination market due to transportation issue.
- 2.7** Supplier shall arrange necessary manpower for unloading of crates/cartons at the delivery points and loading of empty crates at destination points.
- 2.8** Supplier undertake to bring back the empty container (Plastic Crates) and return to their point of origin as and when required by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED and will keep account of its quantity as well. In case of short returning of crates, the amount of crate (Rs 400/- per crate) will be charged and deducted from the billed amount either on monthly or bi-monthly or quarterly basis.
- 2.9** The challan in respect of the Goods shall be signed by the authorized representative of Supplier at the time the Goods are entrusted to Supplier. Supplier shall declare and notify the names of such authorized person from time to time.
- 2.10** All products temperature related issues should be highlighted at the time of delivery of the goods. Once the "Delivery or Trip" is concluded under definition of this agreement, Supplier is not liable to entertain any claims relating to the delivery products.
- 2.11** Supplier will not accept product if it does not meet the agreed temperature requirement at the time of pickup, until it is highlighted on challan & approved

by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED in writing. Supplier should deliver the goods at the same temperature as the goods were lifted from MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED dock. If the temperatures at delivery points are found to be higher, then MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED has the right to impose penalty on Supplier. After the delivery of the consignment, Supplier shall deliver the receipt of acknowledgement by the person(s) to whom the Goods were delivered to MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED and such other receipts and acknowledgment or any other Document that shall be obtainable by Supplier.

- 2.12 In the event that the Vehicle meets with an accident, Supplier would furnish FIR or such other documentation to the satisfaction of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED and send intimation immediately to the MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED, at the address given in this agreement as well as to the loading and delivery stations. The carrier will also take following action for the minimization of loss en-route after consulting with MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED:
 - 2.12.1 Arrangement of another refrigerated van of same capacity for the transshipment whether own or hired.
 - 2.12.2 Immediate repairing of the Refrigerated vehicle enroute to get required temperature.
- 2.13 Supplier shall ensure that at the time of taking the delivery of the consignment, all the relevant documents are received by them from the loading point. In case of any incomplete documentation, Supplier may refuse to accept such consignments.
- 2.14 MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED shall abide by all the required licenses, approval and permissions required for transportation of its Products in the Vehicle. Any duties/levies/charges by any statutory authority on the said Products shall be payable by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED. If in case, Supplier staff/driver/conductor is required to make any payment, the same shall be recoverable from MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED against valid receipts for which MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED shall make the payments on immediate basis or provide equivalent cash to the Supplier staff.
- 2.15 In case the said Vehicle is seized by any authority for any reason attributable to the Products of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED, it will be duty of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED to get the said Vehicle released immediately. If the vehicle is impounded by authority, for reasons other than attributable to the Products, the responsibility to release the vehicle would lie with the transporter, so that the vehicle delivers the products at delivery point as per agreed temperature and quality of products and agreed timelines.
- 2.16 It is the responsibility of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED or its consignee to insure the goods for the Transit Risks/Damages. In case of any untoward incident/accident and subsequent damage of products, it is the responsibility of the transporter to provide MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED with all

relevant documents like FIR copy, photographs of damages and other related documents necessary for Insurance claim by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED, within 24 hours of the incident.

- 2.17** If the milk and milk products get spoilt at delivery point due to failure of the refrigeration system / breakdown of Vehicle / unplanned stoppages, then Supplier will be responsible and the cost of the milk and milk products will be borne by Supplier.
- 2.18** Supplier is required to park its vehicle within the premises of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED upon returning from the delivery point.
- 2.19** Supplier responsibility is limited to the number of packed packages only. Supplier is not responsible to the product quality, expiry dates, short shelf life of the product, and shortages of inners in a packed package etc.
- 2.20** Supplier should maintain the time in placing of Vehicle at MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED Dairy dock and handing over of crates and deliver the material at the destinations in pre-decided time regularly.
- 2.21** The only escalation to freight charges will be on account of diesel fuel time to time subject to revision of Rs. 1/- litre or more, as mentioned in Annexure-II.
- 2.22** When a consignment is lost in transit and not delivered within a reasonable period of time, the responsibility for loss of such consignment would entirely lie on Supplier. The value of such loss to MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED shall be entirely payable by Supplier to MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED in full and shall be recovered out of the pending freight bills, irrespective whether MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED insured the consignments against such loss or not. It would be entirely at MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED's discretion, whether to file a claim on Insurance Company for such loss or not.

3. COMPLIANCE

- 3.1** Supplier shall ensure that all the Vehicles/staff of Supplier carrying the Goods entrusted to them have necessary permits (state permits or any other permits) that may be required. The same shall be made available to their drivers or other relevant persons responsible for the movement of the Goods entrusted to them. Supplier shall be liable for all actual or constructive claims, penalties, loss, damage that may arise on account of such non-compliance.
- 3.2** Supplier shall acquire all the requisite license(s), consent(s), approval(s), registration(s) etc. from the appropriate authority(s) enabling it to provide the services specified under this agreement.
- 3.3** While replacing deployed vehicles, brand new vehicles (with all three components of vehicle like chassis, refrigerated unit and container) should only be provided with prior consent of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED.

- 3.4** All refrigerated vehicles should have installed with approved data & GPS logger (Gemini (Tiny Tag) or Escort) in working condition/VTS with temperature sensor with access of relevant data to MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED on real time basis. In case of having non-active data logger/VTS/temperature report then a penalty will be imposed (@Rs. 500/- per trip or maximum Rs. 5000/- per month). The consolidated report to be attached with bills on monthly basis.

4. CONSIDERATION AND PAYMENT

- 4.1** Supplier shall present the bills in favour of the "MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED – A/c MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED" by 2nd of every month, to MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED after completion of the month. MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED shall release the payment within 30 days of presenting the said bills by Supplier.

5. LIABILITY

Supplier will be liable for providing FIR copy & Certificate of fact (COF) to MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED in order to enable the claim of damages/losses from Insurance Company.

6. FORCE MAJEURE

- 6.1** If at any time during the term of the contract, the performance of either of the parties is prevented or delayed, in whole or in part, by reason of:
- 6.1.1 War, hostilities (whether or not war is declared) or act of an enemy of the crown, riot, rebellion, civil commotion, strikes, bandhs, military/usurped power, revolution, epidemic, fire, accident, wind, flood, terrorist activities, earthquake, proclamation or any Act of God.
 - 6.1.2 Order of the government, public or local authority.
 - 6.1.3 Natural Disaster.

The party whose performance is delayed or prevented, shall be relieved of their obligation to the extent of their performance is delayed by such conditions.

7. TERMINATION

- 7.1** This agreement may be terminated by either party upon giving one-month prior written notice to the other.
- 7.2** Either party may terminate forthwith in case the other party:
- 7.2.1 Commits a material breach of the agreement.
 - 7.2.2 Commits any act prejudicial to the interest of the other party.
- 7.3** By either party, in case a winding-up decree has been obtained against it or enters into liquidation or commits an act of bankruptcy or has an administrator/receiver appointed over its assets.

- 7.4 Termination of this Agreement shall be without prejudice to the acquired rights and obligations of the parties existing at the date of termination and shall not affect any other rights and remedies available.

8. COMPLETE AGREEMENT

- 8.1 The terms of this agreement shall override and render inapplicable any inconsistent terms elsewhere.
- 8.2 This agreement supersedes all previous correspondence and agreements between the parties.

9. NO AGENCY

- 9.1 Nothing in this agreement is intended to create or constitute a principal-agent relation between the parties. The Agreement shall operate solely on a principal-to-principal basis.
- 9.2 Supplier shall carry and convey the goods under this agreement through their own/contracted employees and laborers. Supplier's employees shall not be construed as employees of MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED. Supplier shall be solely responsible for wages and claims under Workmen's Compensation Act 1923 or any other applicable law.

10. ASSIGNMENT

- 10.1 This Agreement is personal to the parties and may not be assigned in whole or in part by either party without prior written consent of the other.

11. ARBITRATION

- 11.1 Disputes to be settled amicably within 30 days; failing which, referred to sole arbitrator appointed by MANIPUR MILK PRODUCERS' CO-OPERATIVE UNION LIMITED. Arbitration governed under Arbitration and Conciliation Act, 1996 (as amended). Venue: Imphal. Language: English. Award binding on both parties.

12. JURISDICTION

- 12.1 The courts of Imphal shall have exclusive jurisdiction to try disputes arising out of this Agreement.

Annexure-II

Commercial Terms & Conditions and Rates
